BHE GT&S is an interstate natural gas transmission and storage company with operations in 10 states and total assets of 5,400 miles of pipeline and 756 billion cubic feet (bcf) of storage.

In Pennsylvania, through our operating company Eastern Gas Transmission and Storage (EGTS), we operate 1,484 miles of interstate pipeline, 32 compressor stations and 11 natural gas storage fields. Our operating company Pivotal LNG operates our small-scale liquefied natural gas (LNG) facility, Towanda LNG, in Wyalusing, Pennsylvania. With its flexible solutions, Towanda LNG provides affordable and reliable LNG to the East Coast for a variety of customers, including commercial, industrial, local utilities, power generation, transportation, marine bunkering and more.

Thanks to our proximity to the Marcellus & Utica shale gas production region, we have the capability to deliver gas when and where it is needed the most.

OPERATIONAL EXCELLENCE

EGTS is frequently recognized for its outstanding safety record, most recently by the American Gas Association (AGA) as the Industry Leader in Accident Prevention. EGTS also closed 2022 with its best year on record for OSHA recordable injuries. Since entering service in 2021, Towanda LNG has maintained a record of zero OSHA recordables and zero vehicle preventable accidents.

REGULATORY INTEGRITY

Our pipeline and storage systems are nationally regulated by the Federal Energy Regulatory Commission (FERC), the Pipeline Hazardous Material Safety Administration (PHMSA) and the Environmental Protection Agency (EPA).
