I serve as Chairman of the Environmental Resources and Energy Committee of the Pennsylvania Senate. I am writing to express my support for Eastern Gas Transmission and Storage's (EGTS) application to the Federal Energy Regulatory Commission (FERC) for its Capital Area Project.

It is my understanding that that the Capital Area Project would include upgrades to four existing compressor stations, including three in Pennsylvania and one in Virginia. These upgrades, which include replacement of gas coolers along with installation of new turbines and electric motors, will result in increases in delivery from natural gas storage fields in central Pennsylvania to natural gas utility customers across the east coast.

Currently Eastern Gas Transmission and Storage operates close to 4,000 miles of pipeline. They safely move natural gas from production fields, storage fields and to end users to help meet the needs of residential and commercial customers across the region. EGTS has played a vital role in delivering reliable, clean and affordable energy to millions of customers.

It is critical to note, this project will not involve the construction of any new pipeline or related facilities. I urge FERC to give this application a favorable consideration in a timely manner.
