As the Pennsylvania State Senator representing Franklin and Adams Counties, I take great pride in watching our region prosper and grow. I have observed Pennsylvania, West Virginia, and Ohio experience tremendous economic activity because of Marcellus and Utica Shale activity. This upswing in local opportunity would not be possible without the influx of business resulting from energy infrastructure development. Companies like Eastern Gas Transmission and Storage, Inc. (EGTS), which construct and operate interstate natural gas facilities and has a significant presence in Franklin County, are literally fueling the local and U.S. economy.

Through the proposed Capital Area Project, EGTS will add additional compression at its Chambersburg Station which is in my district.
